This certificate is issued on the condition that the firefighting systems installed will be kept always functional and the owner of the building should take special care to maintain the systems installed in the proper working condition. This certificate is valid for one year from the date of issue. After One year the certificate must be renewed. Non-renewal of the certificate within the time limit will result in loss of eligibility for insurance coverage and appropriate legal action by the local self Government Revenue Department. All officers of and above the rank of Station Officers of the Fire & Rescue Services Department will have the right to inspect the building on any day/time after serving 7 days' notice to ensure that the installed systems are in good working condition.

4. This No Objection Certificate pertain only to the fire fighting arrangements installed in the building. The civil construction shall be got inspected and approved by the appropriate local authority.
